

Delivery to UK Mainland Addresses

Delivery will be made by CCCL from its facilities throughout the United Kingdom, where possible on our own transport. In other cases, we may use carriers for deliveries that are outside of our usual scope of delivery. This includes timed or overnight deliveries and deliveries to inaccessible areas within the UK (which may incur additional charges of which we will inform the customer in advance).

Delivery is only available for **UK mainland** deliveries. Refer to map on next page for deliveries by branch

The service includes the following postcodes in Scotland;

- DD all postcodes except remote areas of DD8 and DD9,

- EH All postcodes except EH 43 - 45 and EH42 east of Dunbar.
- PA PA1 - 19 only
- PH PH1 - 9
- DG all postcodes except DG5 - 9, DG14, 18 and 19
- KA all postcodes except KA26 - 28.

We do not cover any **IV**, **TD** or **KW** postcodes.

Clean Air Zones

A Clean Air Zone (CAZ) is an area where special measures are taken to improve air quality. In 2010, the UK signed up to a number of limits on air pollution – including limits on harmful nitrogen dioxide (NO2) emissions. London has been operating a CAZ for over a decade.

HGVs that do not meet the emission standards are charged £100/day. From 25 October 2021 the ULEZ will be extended to the North and South Circular roads. Traffic using those roads but not entering Central London will not be charged. On March 15th 2021 Bath will be introducing Clean Air Zones at a cost of £100 per vehicle per day for deliveries in the city, this will be shortly followed by Bristol. From 1st June 2021 Birmingham Council also charge £50 per vehicle per day for deliveries within the City. And from April 2022 other CAZ will be appearing in Manchester.
