NA2XS(F)H cable is suitable for external installation. Cables can be fixed on cable trays, within conduits or fixed to walls and is suitable for burial in ducts. The cable has two waterblocking layers and a UV Resistant Low Smoke, Zero Halogen (LSZH) outer sheath.
